

Foreword

HCM RIPA Jaipur is a state level training institute where senior and middle level officers of the All India Services, State Services of Government of Rajasthan, Public Sector Undertakings and Other States receive trainings. Trainings at the Institute are need based keeping in view the present context and the changing scenario. The courses are organized in the area of Public Administration, Financial Management, Information Technology & e-Governance, Gender Issues, Right to Information etc.

In the financial year 2018-19, 273 training courses were conducted at our Jaipur campus and four Regional Training Centres located at Udaipur, Bikaner, Jodhpur and Kota wherein 10,903 participants were trained.

The Courses sponsored by the Department of Personnel and Training, Government of India, officers of Indian Foreign Services, Indian Forest Services, Indian Police Services, Education cum Field visit of Mizoram and Nagaland State Civil Services, DANICS Mid-Career training programme, are to name a few which we successfully conducted in the year 2018-19. At present various International Trainings cum Study Visits in collaboration with the National Institute for Labour Economics Research & Development (NILERD), New Delhi are already taken up by the institute.

- Provides leadership and guidance to other training establishments in the state in respect of training techniques and other related subjects.

HCM RIPA has a spread-out green campus, located in the idyllic surroundings in the heart of Jaipur City on the Jawaharlal Nehru Marg that links the Jaipur Airport with the City Centre. With a perfect picture of serenity, it is an ideal place for the pursuit of excellence.

ABOUT THE INSTITUTE

The Rajasthan Administrative Service Officers' Training School was established on 14th November 1957 in Jodhpur. It was then known as The Rajasthan Administrative Service Officers' Training School until 20th February 1959. Since, the trainings there were imparted to only Rajasthan Administrative Service probationers. This institute also known as OTS was shifted from Jodhpur to Jaipur in the year 1963 and functioned in the Peera Mal Hotel till 1966. It was later shifted in the new building known as Patel Bhawan in the present premises.

In the year 1969, The Officers' Training School (OTS) was rechristened as "Harish Chandra Mathur State Institute of Public Administration" (HCM SIPA), after the name of Shri Harish Chandra Mathur (22 June 1904 - 12 June 1968) who was a distinguished Administrator and a Parliamentarian from Rajasthan State.

The Government of Rajasthan prefixed "Rajasthan" before the word "State" in the name of the Institute in April 1983. Thus, HCMSIPA was recognised as HCM RIPA (Harish Chandra Mathur Rajasthan State Institute of Public Administration). Today, the Institute is an apex level state training institute of the Government of Rajasthan for imparting trainings to the state civil service's officers and has emerged as one of the front-ranking training institute not only in India but abroad also.

HCM RIPA is spread out in nearly 60 acres of land with lush green campus, and is located in the heart of the Jaipur City on the Jawahar Lal Nehru Marg that links the Jaipur Airport with the City Centre. With a perfect picture of serenity, this is an ideal place for the pursuit of excellence.

Regional Training Centres

HCM RIPA has 4 Regional Training Centres located at Udaipur, Bikaner, Jodhpur and Kota. These centres conduct foundation trainings, refresher courses, workshops and seminars for the officers of the state and subordinate services. The first regional centre was established on 1st December 1982 at Udaipur. The Udaipur centre has a well maintained campus with a library and a hostel to accommodate 90 trainee officers at a time. Recreational facilities are also available on the campus.

In August 1983 other regional Centres were also established at Bikaner, Jodhpur and Kota. These centres mainly cater to the training needs of the subordinate accounts services. Computer training facilities are also available at all the regional training centres.

- Public Systems Management/ Delivery of Public Services
- Disaster Management
- Training of Trainers (Delivery and Design of Training)
- Sensitization on Issues of Minorities and Marginalized Groups

Faculty

HCM RIPA has a team of professional trainers comprising of both practitioners in the Government and academics in relevant disciplines. The disciplines like management, public administration, information-technology, urban development, behavioural sciences, economics, financial management, Government accounts, sociology and physical education are represented by the eminent and experienced faculty members. Most of the faculty members have undergone various trainings organised by the Government of India. To name a few are Direct Training Skills, Design of Training and Management of Training courses. Amongst the faculty one is a Master Trainer (MT) and two are Recognised Trainers (RTs) in delivery, design and evaluation of training. One of the faculty has also been recognized as a Trainer in e-Governance. A number of faculty members have also been trained abroad.

Activities

<u>Training</u>: The major activity of HCM RIPA is to conduct the foundation and Institutional- professional trainings for officials recruited in various state services of the state. The institute also organises professional training for the officers of Indian Administrative Services of the Rajasthan Cadre. Regular in-service training programmes are also conducted in the Institute for officers working in various state/central departments/undertakings in Rajasthan.

Examinations: As part of its major responsibilities HCM RIPA also undertakes Departmental Examinations for Government functionaries of various level. The Institute conducts Departmental Examinations (DEs) for Foundation and Institutional Courses for the State Services and various Departments of the State Government.

Research: HCM RIPA and its Regional Centres also undertake various research and evaluation studies for improvement and management of public policies and programmes.

<u>Training Material Development and Publications</u>: HCM RIPA's publications include training monographs, occasional papers, case studies, experience sharing, write-ups, booklets, books, seminar reports, conference proceedings, training policy documents and journal - Prashasanika which was launched in 1972.

Training Methodology

Programmes developed at the institute are highly participative and knowledgeenhancing. The traditional lecture method continues to be important in training programmes and courses, particularly for probationers. In addition, a variety of audiovisual aids as well as computers, psychological and management games are also a part of the training courses.

Infra-structure Facilities

The institute has a 60 acre spread-out campus at Jaipur, located in idyllic surroundings. The infrastructural facilities comprise classrooms, conference rooms, committee rooms, faculty rooms, library, canteen, computer training centre, an auditorium and a film studio. The Institute's hostel (Vishranti) has the capacity to accommodate more than 250 trainee officers at a time. There are furnished Cottages and a Guest House for the visiting faculty. Facilities for various indoor and outdoor games like tennis, badminton, volleyball, cricket, swimming and gym are also available here. The Institute has video conferencing facilities. All the classroom at Jaipur have integrated digital podium which includes LCD projector, computer and an audio system.

Information Technology Infra-structure

The Institute's Jaipur campus has state-of-the-art IT infrastructure with a fully integrated campus-wide networking of more than 150 computers having Internet access. There are two computer labs with a capacity to train nearly 55 participants at a time. Computer Training Centre has a facility of video conferencing which can be used for broadcasting sessions at Udaipur and Bikaner training centres. Most part of the campus is Wi-Fi enabled.

Library

HCM RIPA has an excellent library having a collection of about 65,000 books in the areas of social sciences, public administration, management, computer sciences, disaster management, rural development, economics, urban development, women and child studies etc. Besides subscribing to about 125 journals and periodicals, it also receives on a regular basis annual reports from national and other state organisations. The library runs on indexing software - ALICE.

Our Partners

In our pursuit of excellence many National and International organisations have sponsored training courses and collaborated with us. Some of them are UNDP, UNICEF, World Bank, HUDCO, various ministries/departments of Government of India including Department of Personnel and Training, Urban Development and Housing, Ministry of Information Technology and Communication, Women and Child Development, Administrative Reforms and Public Grievances, Minority Affairs, Statistics and Programme Implementation, External Affairs, Disaster Management and Relief. Besides this, HCM RIPA has also established its professional relations with Centre for Public Innovations (CIPS), Election Commission of India and Haryana Institute of Public Administration.

Our Organs

The RIPA is supported by following in-campus associate bodies:-

<u>Centre for Management Studies (CMS)</u>: The Centre for Management Studies (CMS), founded in 1982, is an autonomous body, is instituted by various public sector undertakings, with the objective to promote the study of public management systems through education, training, research and consultancy. It has now a long-standing expertise in the field of management training.

The CMS and HCM RIPA jointly undertake training courses for Government/Public sector undertakings' employees, training modules/material preparation workshops, training of trainers' courses and selective research projects. The Centre is also undertaking Induction Training Programmes (ITP) at Jaipur, Udaipur, Bikaner, Jodhpur and Kota divisions to cover regional districts, which are sponsored by Department of Persnonnel & Training, Government of India, New Delhi.

<u>Centre for Disaster Management (CDM)</u>: has been made a part of the Centre for Management Studies. It is funded by State Department of Disaster Management and Relief, Government of Rajasthan for organizing capacity building training programmes on Disaster Management. The Centre is working on mission mode in collaboration with the State Government.

Child Resource Centre: The Centre was established as a sub-centre under the Centre for Management Studies in 2016. It is supported by UNICEF and Department for Child Rights. The Centre has a mandate to raise public awareness, educate public on child rights and protection, on situation and vulnerabilities of children and families, on available child protection services, schemes and structures at all levels. In order to ensure professional services at all levels, the Centre undertakes regular training and capacity building programmes of all service providers and functionaries to equip and enhance their skills, sensitivities and knowledge on child rights and standards of care and protection the children deserve.

Centre for Good Governance: The Centre for Good Governance (CGG) was established and registered as a society on 31 March 2005 in the Institute with a view to coordinate and support the designing and implementation of the State Government's "Governance Reforms Programme". It undertakes action-research programmes, provides professional advice, and conducts change management programmes for the Government Departments and other concerned agencies. This way, it also caters to the needs of policy makers, civil servants, and representatives from industries, academics, research institutes and non-governmental organisations for implementing the reform initiatives in the state.

The goal of the CGG is to bring excellence in the Governance system of the state and to strengthen institutions of civil society for making them sustainable. The focus is on the creation of a strong knowledge-base by conducting action research studies on Government and other organizations; improving outcomes and developing tools and techniques for performance, audit of organizations and persons; and capacity building programmes for the stakeholders.

Centre for Urban Development and Housing. The "Rajasthan Shahari Vikas Kendra" (RSVK) is a state level training centre under the Rajasthan Urban Sector Development Program. The centre is dedicated to carry out urban sector reforms and need based Training to all elected representatives of urban local bodies, urban sector professional and support staff. The dedicated urban sector centre is set up within the premises of HCM RIPA with administrative control placed with Director of HCM RIPA. At present the centre is financially supported by RUIDP (Rajasthan Urban Infrastructure Development Project) under program loan from ADB.

RAJASTHAN STATE TRAINING POLICY, 2008

HIGHLIGHTS

- The Rajasthan State Training Policy 2008 re-affirms the State Government's commitment to take steps for the appropriate and optimum development of the human resources available with the Government so that they can serve the people of the State in a better manner.
- The policy consciously aims at fostering the development of the Human Resources available with the State Government so as to raise their competencies.
- As per the Vision of the policy, public service training and development is to be geared in assisting Government Departments for better Governance and improved public service delivery by empowering public officials to act as prime catalysts for holistic and equity based transformation of the State.
- In pursuit of the above vision, the training policy sets the Mission to create an institutional framework for optimum productivity of public servants in organizations where they are working in a team or as an individual in their current as well as future roles.
- Following the identification of the major challenges, shortcomings and concerns related to the training function, the State Training Policy has identified the following goals:
 - To enable all public servants to develop their knowledge, skills and attitudes in ways which would optimize their current roles;
 - To inculcate values among all public servants that would strengthen their sense of commitment;
 - To encourage all Government Departments and agencies to regularly review their training needs and requirements, and to provide ways of meeting the required outcomes;
 - To provide opportunities for all employees (officers and staff) to prepare themselves for changing roles, duties and responsibilities;
 - To increase job satisfaction and facilitate career progression;
 - To motivate and enable all public servants to contribute positively to the transformation of the society and economy of the state;
 - To provide not only regular trainings, but also distance education capsules to the Government employees, to enable them to continuously update their competencies;
 - To prepare and implement Training Development Plans for each category of Government servants;

- To prepare and implement personal training development plans for each individual in the services;
- To enhance the quality and status of training and trainers;
- To designate in each government department a training manager with a small training cell;
- To ensure that each state level training institute undertakes strategic planning to improve its quality and output by preparing or reviewing its Vision and Mission Statements, preparation of Vision Documents, of Five Yearly and Annual Action Plans and of training calendars, and ensuring optimal implementation; and
- To consider setting up of a Secretariat Training and Management Institute to cater to all those working in the State Secretariat.
- The State Training Policy has laid down the respective roles and responsibilities for Department of Training (Training Cell), Department of Personnel, Department of Finance, Department of Planning, all Administrative and Secretariat Departments, all Heads of Departments, all CEOs of State Public Sector Entities, HCM Rajasthan State Institute of Public Administration (as the apex training institute), and for all other training institutes in the State.
- The training policy shall be referred as an Authorized Guideline for each Government department/agency and each training institute to prepare their 5 year Operational Training Plans and to implement them.
- Some of the Core Principles of Training as listed in the State Training Policy are:
 - Fostering Improving of Work Procedures.
 - Training for all, with Access and Entitlement to suitable training for all Government servants.
 - Careful determination of training objectives by each Government agency.
 - Training Needs Analysis to determine the training to be provided.
 - Elevating the Status of Training and Trainers.
 - A Competency Development based approach to learning and its outcomes.
 - Integration of policy formulation, strategic planning and implementation with relevant training.
 - Flexibility of training.
 - Career pathing of individual employees to be linked to training.
 - Life Long Learning.
 - Public Training institutions to become learning organizations.
 - Ensuring quality and relevance in all trainings.
 - Effective Design and Delivery of all Training Inputs.
 - Monitoring and Evaluation of Training including feedback from trainees.

Guidelines for Nominating Authorities, Sponsors and Participants:

- 1. The HCM RIPA is the Apex level State Administrative Training Institute (ATI) of Government of Rajasthan. It has spread its wings in all four corners of Rajasthan with its regional training centres located at Udaipur, Jodhpur, Bikaner and Kota. The Institute has maintained high standards of training and strive to achieve excellence in their chosen spheres. Vishranti provides lodging and boarding facilities to the participants.
- 2. Based on a systematic Training Need Analysis through a series of meeting with officials of most of the State Government Departments and Public Sector Undertakings, HCM RIPA has planned variety of training programmes which include Foundation Course, Institutional-Professional Courses, Induction Training, Refresher Training, Management & soft skills training, Institutional and District Training for Indian Administrative Service officers of Rajasthan Cadre. The courses also includes Trainer Development Programmes, Training under State Category Training Programmes of Government of India. The details of these courses to be conducted this year are available in the succeeding pages. This Training Calendar can also be downloaded from Institute's website (www.hcmripa.gov.in)
- 3. For Foundation Training Courses, nominations are made by the State Government, through the concerned Administrative Departments. After the end of the Foundation Course, the probationers undergo Institutional-Professional Training at HCM RIPA and at respective Departmental Training Institutes.
- 4. Nominating authorities may choose the relevant training courses from the Institutes' Training calendar for the officers and nominate them for the trainings. Short term in-service training courses are open for participants of various Government Departments. Circulars inviting nominations are issued by concerned course director's 4 weeks in advance from the date of commencement of each course. Nominations may also be made *suo-moto* on the basis of this training calendar. However, nominating authorities should consult Training and Planning Section at HCM RIPA, before they issue nominations, about any change in training course or dates.
- 5. Nominees are advised to report for the programme / training on first day, i.e. commencement of the training at 9.30 AM in the respective room. They may enquire venue and time from concerned course Director. The contact details of the course director's are given in the directory appended with this training calendar. A LCD projector is placed at the reception which displays the venue of the programme to facilitate the trainees and the participants to reach the designated class room.

- 6. HCM RIPA follows 5 days a week schedule. Working hours are from 9.30 to 6.00. Holidays declared by General Administration Department of State Government are applicable in HCM RIPA.
- 7. No course fees is charged for training courses shown in RIPA category. Local participants are invited in training courses free of cost. The accommodation for the outstation participants can be arranged in the institute's hostel-Vishranti for which charges are to be paid directly for accommodation, bed tea, breakfast and dinner as per rates applicable. However, there are no charges for lodging and boarding for outstation participants, if the course(s) is sponsored by Department of Personnel and Training, Government of India.
- 8. We accept nominations from the concerned Department(s) in demand based customized paid courses. Such courses are offered through Centre for Management Studies (CMS).
- 9. Nominating authorities may send the nomination order stating name, designation, department, Mobile Number and e-mail of nominees to concern course director/Officer-in-Charge (Training and Planning) HCM RIPA, Jaipur. To facilitate the Course Director with respect to the arrangements to be made for the course. All correspondence concerning training courses should be addressed to the concerned course director/Officer-in-Charge (Training and Planning). User Departments are advised to refer the last page for telephone, fax, mobile numbers and email-id of Course Directors concerned. The nomination may also be sent through email of the institution i.e. hcmripa@rajasthan.gov.in.
- 10. The nominations are usually accepted on first-come-first basis.
- 11. Nominating authorities should ensure that nominees utilize knowledge and skills acquired during the training once they are back to their respective organizations.
- 12. To promote Gender equality in training and development opportunities, adequate nomination of women participants should be ensured by the nominating authorities.
- 13. In case, Heads of Departments realize that there is special training need for their department due to new recruitment or promotion they may contact HCM RIPA, so that need-based customized training courses can be designed and offered to the Department.
